The goal of this junior league is for players to experience the game of golf in a fun, competitive environment. We want to increase player awareness and readiness in an effort to speed up play

Come join one of our 2023 spring teams. Each participant will receive a team hat, six instructional practices, and four 6-hole* competitions. Each **Team** competition is a two-person scramble and teams will consist of up to 10 kids ages 8 to 14, both boys and girls. Players cannot turn 15 before May 14, 2023. ALL matches will be played at Turnberry GC from April 22 through May 13. Competitions are played from the Family tees and are 6 holes in length but ALL players may play up to 9 holes as long as they finish teeing off their 9th hole by 6:00 pm. After six holes, one team is awarded a point for their team. At the end of the competition, the team with the most points wins. There are NO subs – all players will play each hole.

Practices are on Tuesdays at 6:00pm or 7:00pm starting April 4.
